RE: GERBER RECALLS SELECT ARROWROOT BISCUITS DUE TO POTENTIAL FOREIGN MATERIAL



Amador County, CA: Gerber Products Company has voluntarily recalled limited batches of *Gerber® Arrowroot Biscuits* because they may contain soft plastic and/or paper pieces that should not be consumed, the U.S. Food and Drug Administration and company officials announced.

The recall applies to 5.5-ounce packages of the biscuits with “Best Before” dates from Oct. 16 through Dec. 16, 2026. Parents and caregivers should check the 10-digit batch code on the back of the package to identify affected lots.
